Release of Liability:

In consideration of my child, _____ (the "Child"), being allowed to participate in the Yarmouth Football Association ("YFA") program, related events and activities, I acknowledge and agree that:

1. Football is a competitive contact sport that poses the risk of serious injury, including the potential for permanent disability and death, and while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury does exist.
2. I knowingly and freely assume the risks of the Child's participation, both known and unknown, even if arising from the negligence of others and assume full responsibility for the Child's participation.
3. I agree individually, and on behalf of the Child, not to institute, or commence any action at law or equity for any injury or damage that may be sustained by the Child as a result of participation in the program. I agree to indemnify and hold harmless YFA, its directors, the coaches, sponsors, participants, persons transporting the Child, and volunteers from any claims, demands, or actions at law or equity that may be brought by or on behalf of the Child to recover for injuries or damages arising from participation in the program, whether from negligence or any other cause.
4. I represent that the Child is medically fit to participate in the program. I have adequate medical health insurance to cover the Child in case of injury received while participating in the program and will report all injuries of the Child to the Child's coach within 24 hours of their occurrence.
5. I give YFA permission to use the Child's photo without the Child's name on the web and to use the Child's photo, name, height, weight, and number in rosters and other printed materials to be distributed to YFA football game attendees and as otherwise required in connection with games. I understand that YFA does not need my consent to each use of such material.

Parent's acknowledgement

I acknowledge the following:

1. Families are responsible for providing the following equipment, sanctioned for competitive football: shoulder pads, helmet, mouth guard and pants with lower extremity pads, and appropriate footwear.
2. Any uniforms YFA provides for use during the season must be returned at the end of the season. A player's family shall pay \$50 to YFA for any uniform that is not returned to YFA by November 30, 2009.
3. All football players (grades 1 – 8) are responsible for selling and remitting payment to YFA in the amount of \$150 football raffle tickets by September 28, 2009. All High School players are responsible for selling and remitting payment to YFA in the amount of \$250 by September 28, 2009. On September 28, 2009, the football player or the football player's family will be responsible for contributing the difference if the football player has not raised at least \$150/\$250 through the sale of raffle tickets.
4. There is no refund of registration fees after a child has attended three practices in full equipment.
